WHEREAS, **I**, the said **J.H. McWhite**

in the full and just sum of **Five hundred**  
Dollars, to be paid **one year from date**

with interest thereon from **July 1st, 1921** at the rate of **8** per cent. per annum to be  
computed and paid **semi-annually**

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

**ten per cent** besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said **Henry P. McGee, his heirs and assigns all that piece, parcel**

**or part of land situate, lying and being in Greenville County, State aforesaid in Gantt Township, containing 53.8 acres, more or less, and having the following metes and bounds: Commencing at a stone on road leading to house; thence S. 55.10 W. 1254 to a stone; thence S. 29.10 E. 2131 feet to a stone; thence N. 21.30 E. 1010 feet to a stone; thence N. 30.25 E. 1317 to pine; thence N. 64.40 W. 1164 feet beginning corner as per plat of said lands by R.E. Dalton, Engineer July 1916 and being a part of lands Mrs. F.E. McWhite, deceased aforesaid known as tract No. 1 on said plat, conveyed to me 29th, Sept. 1916 and recorded in Vol. 41 page 494, R.M.O. Greenville County, South Carolina.**
