SEND GREETING:

WHEREAS, I, the said Frank C. Wright  
in and by my certain promissory note in writing, of  
even date with these presents, W.N. Dodd well and truly indebted to

in the full and just sum of Twenty-five Hundred (\$2500.00)  
Dollars, to be paid fifty (\$50.00) Dollars, or more at option of maker on  
first day of each and every month, beginning with December  
1, 1921, until paid in full. The total of any amount remain-  
ing due, to be due and paid all three years from the date  
herof, with interest thereon from November 10th, 1921 at the rate of Eight per cent. per annum to be  
computed and paid semi-annually

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of amount  
due besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That Frank C. Wright  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said W.N. Dodd  
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said Frank C. Wright  
in hand well and truly paid by the said W.N. Dodd

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said W.N. Dodd, his heirs and assigns forever,

All that certain piece, parcel or lot of land, lying, situate and being in the City of  
Greenville, County and State aforesaid, known and designated as lot No. 34, Block B, of Cagle  
Park, as shown on plat recorded in the office of Register of Mesne Conveyance, for Greenville  
County, in Plat Book C, at page 238, and having the following metes and bounds, to-wit:  
Beginning at an iron pipe on Tindal Avenue, corner of lot No. 33, and running thence S. 0-53  
E. one hundred fifty (150) feet to an iron pipe; thence S. 89.07 W. sixty-one (61) feet to  
an iron pipe; thence N. 0-53 W. one hundred fifty (150) feet to an iron pipe on Tindal Ave.  
at corner of Lot No. 35; thence with Tindal Avenue N. 89.07 E. sixty-one (61) feet to the  
beginning corner, being the same lot of land conveyed to W.N. Dodd by E. Imman, Master on the  
7th, day of November 1921.

It is understood and agreed that this mortgage is given to secure a part of the purchase
