Cothran am indebted in and by my certain promissory note dated February 8th 1922 in the sum of Seven Hundred (\$700.00) Dollars payable Ten months after date unto Belton Savings + Trust Co Belton S.C. with discount before and interest after maturity at the rate of eight per cent, per annum until paid. Interest to be computed and paid annually, and if said interest is not paid annually, it is to be added to and become part of the Principal, and the whole bear interest at the same rate until the whole is paid in full.
