

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, B. H. Bishop ⁶⁰ of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, the said B. H. Bishop in and by my certain bond or obligation, bearing date the 19th day of June 1921, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Twenty Seven Hundred + no/100 (\$2700.00)

conditioned for the payment of the full and just sum of Twenty Seven Hundred + Fifty + no/100 (\$2750.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 8th day of June 1921,

according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that B. H. Bishop shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of June 1921,

and on the 20th or before the end of each month thereafter, for twenty successive months, the sum of Twenty Two + 50/100 (\$22.50) Dollars 1921 #13.50 Dollars,

being the regular monthly installment payable on the 13 1/2 shares of stock, and Nine + no/100 (\$9.00) Dollars

being the monthly interest on the advance (or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty + 70/100 (\$20.70) Dollars #13.50 Dollars,

being the regular monthly payment on said stock and Eighteen + 20/100 (\$18.20) Dollars being the monthly interest on balance due); for the next twenty months the sum of Eighteen + 90/100 (\$18.90) Dollars,

Dollars being the regular monthly payment on said stock and Eighteen + 10/100 (\$18.10) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Eighteen + 17/100 (\$18.17) Dollars,

being the monthly payment on said shares of stock and Three + 60/100 (\$3.60) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Fifteen + 30/100 (\$15.30) Dollars,

Dollars being the monthly payment on said shares of stock and One + 80/100 (\$1.80) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 13 1/2 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said B. H. Bishop and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said B. H. Bishop

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said B. H. Bishop in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said B. H. Bishop

in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

Situate about two and one half miles north of the City of Greenville known as San Souci and being known and designated as Plot no. 38 Block B of Mountain View Land Company as shown by plat made by W. A. Adams and recorded in Plat Book A, pages 396 and 397, and having the following meter and bounds, to wit: according to said plat Beginning at a stake on the west side of Gridley Street, joint corner with lot no. 37 (200 feet from corner of Martin Street and running thence with lines of lot no. 37, N. 89 1/2 W. 150 feet to a stake on a ten foot alley; thence with said alley, in a northerly direction 50 feet to a stake joint corner with lot no. 39; thence with line of lot no. 39 S. 89 1/2 E. 149 feet to a stake on Gridley Street; thence with said Gridley Street S 13 E. 50 feet to the Beginning Corner, and being the same lot of land conveyed to me by Mountain View Land Company by its deed dated March 2nd, 1921 and recorded in Volume 29 Page 41, R. M. C. Office for Greenville County.
