

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mrs. W. N. Westmoreland, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Mrs. W. N. Westmoreland in and by my certain bond or obligation, bearing date the 2<sup>nd</sup> day of July 1921, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Twenty-six hundred & no/100 (\$2,600.00)

conditioned for the payment of the full and just sum of Thirteen hundred & no/100 (\$1,300.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly from the 2<sup>nd</sup> day of July A. D. 1921 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I the said Mrs. W. N. Westmoreland shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly on the 20th day, or before the end of the month of July 1921, and on the 20th or before the end of each month thereafter, for twenty successive months, the sum Twenty-one hundred & no/100 (\$2,100.00) Dollars (\$13.00) Dollars, being the regular monthly installment payable on the Thirteen shares of stock, and Eight & 67/100 (\$8.67) Dollars being the monthly interest on the advance or loan, until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Nineteen & 93/100 (\$19.93) Dollars (\$13.00) Dollars, being the regular monthly installment on said stock and Six & 93/100 (\$6.93) Dollars being the monthly interest on balance due; for the next twenty months the sum of Eighteen & 7/100 (\$18.20) Dollars, (\$13.00) Dollars being the regular monthly payment on said stock and Five & 7/100 (\$5.20) Dollars being the monthly interest on balance due; for the next twenty months pay the sum of Eighteen & 7/100 (\$18.20) Dollars (\$13.00) Dollars, being the monthly payment on said shares of stock and Three & 47/100 (\$3.47) Dollars being the monthly interest on balance due; for the next twenty months pay the sum of Fourteen & 73/100 (\$14.73) Dollars, (\$13.00) Dollars being the monthly payment on said shares of stock and One & 73/100 (\$1.73) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said Thirteen shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said Mrs. W. N. Westmoreland and shall pay or cause to be paid, all taxes which may be duly imposed upon, or charged against me, the said Mrs. W. N. Westmoreland in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Mrs. W. N. Westmoreland in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said Mrs. W. N. Westmoreland in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

Situate, lying and being near the city of Greenville, State and County aforesaid, being a part of lots 35 and 36 of a plat of said Louis Villa, recorded in Plat Book A page 518 and more fully described as follows.

Beginning at a point on Brockman Street, corner of lot belonging to W. D. Lucas and running thence N. 18-00 E. 62 feet; thence S. 57-25-0. 175 feet, thence S. 10-00 W. 62 feet thence N. 57-25-0 W. 175 feet and being the same land conveyed to me by Sam. McEowan by his deed dated May 3<sup>rd</sup>, 1920, and recorded in Volume 70 page 87, R. M. C. Office for Greenville County, South Carolina.
