

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Alice Allen, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Alice Allen in and by my certain bond or obligation, bearing date the 26th day of May 1922, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Four Thousand + no/100 (\$4000.00)

conditioned for the payment of the full and just sum of Two Thousand + no/100 (\$2000.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 26th day of May A. D. 1922 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I the said Alice Allen shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of May 1922, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum Thirty-three + 33/100 (\$33.33) Dollars (\$20.00) Dollars,

being the regular monthly installment payable on the Twenty shares of stock, and Thirteen + 33/100 (\$13.33) Dollars being the monthly interest on the advance (or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Thirty + 67/100 (\$30.67) Dollars (\$20.00) Dollars,

being the regular monthly payment on said stock and Ten + 67/100 (\$10.67) Dollars being the monthly interest on balance due; for the next twenty months the sum of Twenty-eight + no/100 (\$28.00) Dollars, (\$20.00) Dollars being the regular monthly payment on said stock and Eight + no/100 (\$8.00) Dollars being the monthly interest on balance due; for the next twenty months pay the sum of Twenty-five + 33/100 (\$25.33) Dollars (\$20.00) Dollars,

being the monthly payment on said shares of stock and Five + 33/100 (\$5.33) Dollars being the monthly interest on balance due; for the next twenty months pay the sum of Twenty + no/100 (\$20.00) Dollars, (\$20.00) Dollars being the monthly payment on said shares of stock and Two + 67/100 (\$2.67) Dollars being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the 20th, day of each month, and thereafter surrender to the Company the said 20 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said Alice Allen and shall pay or cause to be paid, all fines which may be duly imposed upon or charged against me or the said Alice Allen in accordance with the Charter, By-Laws, Rules and Regulations as in and to the said Alice Allen or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN that I, the said Alice Allen in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to Five the said Alice Allen in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

Situate on Echols Street in the city of Greenville in the first block off of Buncombe Street and having the following meters and bounds. Commencing on the corner of Lot of L. P. Watson and running thence west with Echols Street 45 feet; thence in a perpendicular line southward 75 feet to a ten foot alley; thence easterly along said alley 45 feet to line of W. E. Phelps; thence along said line and line of L. P. Watson 75 feet to beginning corner, and being the same lot conveyed to me by P. A. Rab by deed dated May 25th, 1922 to be recorded.
