

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Carrie Thompson, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Carrie Thompson in and by my certain bond or obligation, bearing date the 29th day of January 1923, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Seven Thousand & no/100 (\$7,000.00) Dollars,

conditioned for the payment of the full and just sum of Thirty-five Hundred & no/100 (\$3,500.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 29th day of January A. D. 1923

according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner, and form the following, that is to say, that I the said Carrie Thompson shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of January 1923

and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum of Fifty-eight & 33/100 (\$58.33) Dollars,

being the regular monthly installment payable on the Thirty-five shares of stock, and Twenty-Three & 33/100 (\$23.33) Dollars

being the monthly interest on the advance (or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fifty-three & 67/100 (\$53.67) Dollars,

being the regular monthly payment on said stock and Eighteen & 67/100 (\$18.67) Dollars being the monthly interest on balance due); for the next twenty months the sum of Forty-nine & no/100 (\$49.00) Dollars,

(35.00) Dollars being the regular monthly payment on said stock and Fourteen & no/100 (\$14.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Forty-four & 33/100 (\$44.33) Dollars,

being the monthly payment on said shares of stock and Nine & 33/100 (\$9.33) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Thirty-nine & 67/100 (\$39.67) Dollars,

(35.00) Dollars being the monthly payment on said shares of stock and Four & 67/100 (\$4.67) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 35 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said Carrie Thompson and shall pay or cause to be paid, all fines which may be duly imposed upon or charged against me, the said Carrie Thompson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Carrie Thompson in consideration of the said debt and sum of money aforesaid and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of Four DOLLARS, to me the said Carrie Thompson in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville, City of Greenville State of South Carolina, and described as follows:

Beginning at corner of lot No. 2 on Brown street, running thence with Brown street S. 31 W. 51 feet to corner of a street (Davis street) thence with said Davis street S. 55 E. 147 feet to alley; thence N. 31 E. 51 feet to corner of lot No. 3; thence N. 75 W. 147 feet to the beginning corner, being the same lot conveyed to me by J. A. Ballard by deed dated January 22nd 1923, to be recorded.
