

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, W. H. Langley, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said W. H. Langley in and by my certain bond or obligation, bearing date the 18th day of May 1923, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Three Thousand & 7/100 (\$3,070.00)

conditioned for the payment of the full and just sum of Fifteen hundred (\$1500.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 18th day of May

A. D. 1923 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I the said W. H. Langley shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of May 1923, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum

Twenty-five & 7/100 (\$25.00) Dollars (\$15.00) Dollars, being the regular monthly installment payable on the fifteen shares of stock, and ten & 7/100 (\$10.00) Dollars

being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of

Twenty-three & 7/100 (\$23.00) Dollars (\$15.00) Dollars, being the regular monthly payment on said stock and eight & 7/100 (\$8.00) Dollars being the monthly interest on balance due); for the next twenty months the sum of

Twenty-one & 7/100 (\$21.00) Dollars, (\$15.00) Dollars being the regular monthly payment on said stock and

Six & 7/100 (\$6.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of

Nineteen & 7/100 (\$19.00) Dollars (\$15.00) Dollars, being the monthly payment on said shares of stock and Four & 7/100 (\$4.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of

Seventeen & 7/100 (\$17.00) Dollars, (\$15.00) Dollars being the monthly payment on said shares of stock and

Five & 7/100 (\$5.00) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 15 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said W. H. Langley and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said W. H. Langley in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said W. H. Langley in consideration of the said debt and sum of money aforesaid and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said W. H. Langley in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

On South side of Randall Street, beginning on South side of Randall Street 140 feet East from the Southeast corner of Randall and Whitehall Streets; thence S. 1-41 W. 200 feet feet; thence S. 85-39 E. 50 feet; thence N. 1-41 E. 200 feet to Randall Street; thence with Randall Street N. 85-39 W. 150 feet to the beginning corner, and being the Western part of Lot No. 11, Section B. on plat of Stone Lands recorded in Plat Book A, at pages 337-345, and being the same lot conveyed to me by Stella D. Stone by deed dated October 4th, 1922, and recorded in Book 75, page 366, R.M.C. Office for Greenville County.
