TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Lewis Sawgalsky, of Greenville, in the County of Greenville and State of South Carolina, SEND GRATING:

WHEREAS, the said Lewis Sawgalsky in and by my certain ~~bond~~ ^{note} or obligation, bearing date the 24th day of October, 1922, stand ~~firmly held and bound~~ ^{am indebted} unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of fourteen hundred & no/100 (\$1400.00) Dollars, ~~conditioned for the payment of the full and just amount~~

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 24th day of October, A. D. 1922, according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that the said Lewis Sawgalsky shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of November 1922, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum

Twenty Three & 33/100 (\$23.33) Dollars (\$14.00) Dollars, being the regular monthly installment payable on the fourteen shares of stock, and nine & 33/100 (\$9.33) Dollars being the monthly interest on the advance (loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty One & 47/100 (\$21.47) Dollars (\$14.00) Dollars, being the regular monthly payment on said stock and seven & 47/100 (\$7.47) Dollars being the monthly interest on balance due; for the next twenty months the sum of Nineteen & 60/100 (\$19.60) Dollars, (\$14.00) Dollars being the regular monthly payment on said stock and nine & 33/100 (\$9.33) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Seventeen & 73/100 (\$17.73) Dollars (\$14.00) Dollars, being the monthly payment on said shares of stock and three & 73/100 (\$3.73) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Fifteen & 37/100 (\$15.37) Dollars (\$14.00) Dollars, being the monthly payment on said shares of stock and one & 37/100 (\$1.37) Dollars, being the monthly interest on balance due).

By the City of Greenville. Beginning on Strathairn Street, corner of the Pyron lot thence N. 85-30 W. 181.2 feet thence S. 56-30 W. 30.5 feet thence S. 12-20 E. 53.3 feet thence N. 89 E. 187 1/2 feet to Strathairn Street; thence with west side of Strathairn Street 53.3 feet, the beginning corner being same lot conveyed by Charles N Spaight to A. D. Ellenburg deed dated September 23rd 1919, recorded in deed book 56 Page 81, R. M. C. Office for said Greenville County and by Ellenburg to W. L. Jagers and W. L. Jagers to me by deed dated July 12, 1922, and recorded in deed book 94 Page 452 said R. M. C. Office for Greenville County.
