and if unpaid when due to bear interest at same rate as principal until paid, and I..... have further

promised and agreed to pay ten percent. of the whole amount due for attorney fees, if said note..... be collected by an attorney or through legal proceedings of any kind, reference being hereunto had w^t more fully appear.NOW, KNOW ALL MEN That I..... the said *Med L. Bryant*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note..... and also in consideration of the further sum of Three Dollars to me.....

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *L. W. Harris*all that piece, parcel, tract or lot of land situated in *Greenville*

Township, Greenville County, State of South Carolina,

In West Greenville on Perry Avenue and Dale Street, and having the following metes and bounds: Beginning at an iron pin on Perry Avenue and running thence N. 31-59 E. 220.2 feet to Dale Street; thence with Dale Street N. 66-58 W. 161 feet to iron pin; thence S. 20-38 W. 116.3 feet to iron pin; thence S. 71 E. 55 feet to iron pin; thence S. 20-33 W. 115 feet to an iron pin on Perry Avenue; thence with said Perry Avenue S. 71 E. 100.4 feet to beginning corner.

Also that other lot of land in the Township, County and State aforesaid, adjoining the above described lot, on Perry Avenue and having the following metes and bounds: Beginning at an iron pin on the north side of Perry Avenue and on line of W. H. Draine's land and running thence with said Perry Avenue S. 71 E. 55 feet to a pin on Groce line; thence N. 20-33 E. 115 feet; thence N. 71 W. 55 feet to corner on Draine land; and thence S. 20-33 W. 115 feet to beginning corner.
