H. Darlington, Dec'd*,

all that piece, parcel, tract or lot of land situated in *Township* of *Greenville County, State of South Carolina*,

*About 6 miles from Greenville Court House on the White Horse Road, containing 8.10 acres, more or less and known as 4 tracts, no. 1, on plat of property of Charles D. Charles, Survey and plat made by W. J. Phillips, Surveyor, January 11, 1923 and having the following courses and distances according to plat: Beginning at an iron pin in the front of the White Horse Road, corner of tract no. 1, and running westwardly with line of said tract N. 44 W. 6.06 to stake, thence S. 45 E. 10.00 to stake, thence N. 35-15 W. 2.40 to stake, thence S. 4-30 W. 9.10 to stake corner of tract no. 3, thence with line of said tract N. 61 E. 12.00 to stake on White Horse Road, thence with White Horse Road N. 35-30 W. 8.32 to the beginning corner.*
