all that piece, parcel, tract or lot of land situated in *Greenville* Township, Greenville County, State of South Carolina, on the east side of *McD. Avenue in City View, as shown on*

plat made by W.A. Adams, Surveyor, and having the following boundaries: Beginning at an iron pin 200 feet from the South side of Summit Street and running thence with line of lot of D.S. Farnsworth, known as lot No. 11, S. 89-1/2 E. 150 feet to an iron pin on an alley; thence in a southerly direction with the alley 100 feet; thence N. 89-1/2 W. 1150 feet to an iron pin on McD. Avenue; thence with the east side of McD. Avenue 100 feet to the beginning corner, being known as lots No. 109 and 110 on the Adams plat.

Also that other lot of land in the Township, County and State aforesaid, in City View, on east side of McD. Street, known as lot No. 108 on plat of City View Land Co. recorded in R.M.C.
