Dollars, to be paid as follows: One hundred (\$100.00) Dollars November 14th 1923; One hundred ninety (\$190.00) Dollars May 14th 1924; One hundred ninety (\$190.00) Dollars May 14th 1923.

with interest thereon from date at the rate of eight per cent. per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain lot or parcel of land, situate, lying and being in Greenville Township, Greenville County and state aforesaid on the Paris Mountain Road, near the city of Greenville, known and designated as lot no. 58 as shown on a plat of the Perry Estate, of record in the R.M.C. office for Greenville County, South Carolina, in plat book "F" page 124 and having according to said plat, the following metes and bounds to wit: Beginning at an iron pin on Paris Mountain Road, joint corner of lots 58 and 59 and running thence with the Paris Mountain Road N. 16-17 W. 47.4 feet to an iron pin, corner of Paris Mountain Road and Marlin Street; thence with Marlin St. S. 58-30 W. 220.5 feet to an iron stake joint corner of lots 58 and 57, thence S. 31-30 E. 75 feet to an iron pin, thence along line of lot no. 59 N. 58-30 E. 200.2 feet to the beginning corner.
