All that lot or parcel of land situate, lying and being in the City of Greenville at the northeast corner of Bennett Street and East Park Avenue, and having the following metes and bounds, to-wit: Beginning at a point on the north side of East Park Avenue, which point is one hundred thirty and one-tenths (130.1) feet east of the northeast corner of Bennett Street and East Park Avenue, and running thence with the North side of East Park Avenue N. 63-01 W. one hundred thirty and one-tenth (130.1) feet to the northeast intersection of Bennett Street and East Park Avenue; thence with the eastern side of Bennett Street N. 16-30 W. one hundred seventy-five and three-tenths (175.3) feet to a stake; thence S. 63.01 E. one hundred seventy-eight and three-tenths (178.3) feet to a point in the line of a lot to be mortgaged to Metropolitan Life Insurance Company; thence in a southerly direction with the line of said lot, one hundred eighty-four and five-tenths (184.5) feet to the point of Beginning on East Park Avenue.
