WHEREAS, *S. J. Bellwood, Trustee*, the mortgagor, hereinabove named,

SEND GREETINGS:

in and by *1927* certain *note in writing, of even date with these presents, well and truly*
indebted to *R. O. Patterson, Trustee, for \$1,000.00 and W. P. White*
the mortgagee hereinabove named.

three hundred dollars (\$300.00)
to be paid *on or before the fifth day of December, one thousand nine hundred and twenty-one*
dollars (\$300.00) plus interest from the fifth day of December, one thousand nine hundred and twenty-one, to the fifth day of January, one thousand nine hundred and twenty-two.

with interest thereon from *the fifth day of January, one thousand nine hundred and twenty-two* at the rate of *eight* per cent. per annum, to be computed and paid *semi-annually* *paid in full; all interest not paid when due to bear interest at same rate as principal;* and if any portion of principal or interest be at any time past due unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *sixty dollars*.

besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as debt thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind or if any part of the money due on said note be not paid when due (all of which is secured under this mortgage), as in and by the said note, reference being thereto had, will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said

L. O. Patterson, Trustee, for R. O. and W. P. White, and his successors and assigns, all that piece, parcel or lot of land situate, lying and being in the city of Greenville, in the county and state aforesaid, on the north side of Cooper Street, having the following metes and bounds, to-wit:

Begins at a point on north side of said street fifty (50) feet east of Leach Street and running thence $83^{\circ} 47' E.$ fifty (50) feet to a stake on corner of lot No. 16; thence along said lot $50^{\circ} 20' E.$ one hundred and eleven and one-half (111.5) feet to a stake; thence north $60^{\circ} 24' W.$ fifty (50) feet to a stake; thence $30^{\circ} N.$ one hundred eleven and one-half (111.5) feet to the beginning point, and being known as lot No. 15 for a flat recorded in the R. M. L. office for said county in Plat Book "A", at page 159, and being the same conveyed to me, the said R. O. Patterson, by Mrs. S. J. Bellwood, July 20, 1920, deed recorded in said office in Volume 71, at page 114.

There is no other lien or encumbrance on said land by mortgage, judgment or otherwise, except a prior mortgage forty 40° to said R. O. Patterson, Trustee as aforesaid, dated June 4, 1927, and recorded in said office in Mortgage Book 31, at page 227.
