THIS INDENTURE, made the twenty eighth day of May in the year one thousand nine hundred and twenty one between James Davis Bridges, of the County and State aforesaid party of the first part, and THE EQUITABLE LIFE ASSURANCE SOCIETY OF THE UNITED STATES, a corporation organized and existing under the laws of the State of New York, having its principal office at Number 120 Broadway, in the Borough of Manhattan, of the City of New York, party of the second part; the said party of the first part being hereinafter known and designated as the MORTGAGOR, and the said party of the second part being hereinafter known and designated as the MORTGAGEE;

WITNESSETH: WHEREAS, the said mortgagee has issued to James Davis Bridges (known as J.D. Bridges) its certain policy of insurance, bearing register date the first day of June, 1921, and numbered 4913066 agreeing to pay to the beneficiary therein named upon receipt of due proof of the death of the insured, provided premiums have been duly paid and said policy be then in force and be then surrendered properly released, the sum of Six Thousand

(\$6000.00) DOLLARS, all in accordance with the terms and conditions of said policy. WHEREAS, the said mortgagor is justly indebted to the said mortgagee in the sum of Six Thousand

(\$6000.00) DOLLARS, gold coin of the United States of the present standard of weight and fineness, secured to be paid, together with the premiums on said policy of insurance, by a certain bond or obligation, bearing even date herewith, conditioned for the payment thereof at the principal office of the said mortgagee in the City of New York in the County of the City of New York equal monthly instalments, each of the sum of 12.00

(\$96.24) DOLLARS, gold coin as aforesaid, payable in advance on the first day of each successive calendar month, beginning on the first day of June, 1921, and each such instalment, except the first, which does not include interest, including:

- (a) A payment on account of the principal of said loan;
- (b) Interest at the rate of six per centum per annum, duly discounted, on the monthly decreasing balance of said principal sum which will remain unpaid on said loan after the payment of each of the said monthly instalments; and
- (c) The monthly premium on said policy of life insurance, it being in said bond expressly agreed that the whole of said principal sum, or the balance thereof from time to time outstanding, shall become due after default in the payment of any one of said instalments, or of the taxes, assessments or water rates, as therein provided, anything therein to the contrary notwithstanding.

NOW THIS INDENTURE WITNESSETH, that the mortgagor, for the better securing the payment to the said mortgagee of the said sum of money mentioned in the condition of the bond or obligation as aforesaid, with interest thereon, and also for and in consideration of the sum of One Dollar to the mortgagor in hand paid by the mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents do grant, bargain, sell and convey unto the said mortgagee, its successors and assigns, forever:

All that certain lot or parcel of land situate, lying and being in the Second Ward of the City of Greenville, County and State aforesaid, on the east side of North Main Street, in the Block between Stone Avenue and Earle Street, in Block between Stone Avenue and Earle Street, and having the following metes and bounds, according to a plat of R.E. Dalton, to-wit: Beginning at a point on the east side of North Main Street, which point is two hundred twelve (212) feet, eight (8) inches from the southeast corner of Earle and North Main Streets, and running thence S. 73-12 E. two hundred eleven and two-tenths (211.2) feet to a fence post; thence S. 18-07 W. fifty-one (51) feet to a stake; thence N. 73-12 W. two hundred twelve and seven-tenths (221.7) feet to a point on North Main Street, which point is one hundred sixty-eight (168) feet, one (1) inch from the northern curb of Stone Avenue; thence with the eastern side of North Main Street N. 19-48 E. fifty-one (51) feet to the point of beginning.
