AND the said Nannie Downs, agrees to insure the house and buildings on said lot in the sum of not less than full insurable value Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said mortgagee and that in the event the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in his name, and reimburse himself for the premium and expense of such insurance under this mortgage.
