AND the said Mary Phillips Leppard agree to insure the house and buildings on said lot in the sum of not less than fifteen hundred Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said J. J. Fuller and that in the event the mortgagor shall at any time fail to do so, then the said J. J. AND IT IS AGREED, by and between the said parties, that I am to hold and enjoy the said premises until default of payment shall be made.
