All that certain tract of land in Highland Township, Greenville County, South Carolina, known and designated as tract No. A-7 according to a subdivision and plat of property belonging to Henry A. Forrester, deceased, made by W. P. Morrow, August 1930, containing 62.55 acres, and having the following metes and bounds and courses and distances as shown by said plat, to wit;
