Chapman, as Trustee under a Trust Agreement dated Dec. - 1936, their successors and assigns, from and against me and my heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

AND the said R. E. Foil agree to insure the house and buildings on said lot in the sum of not less than Ten thousand (\$10,000) Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said H.
