to be paid on or before the date when the *3rd* Series of the *Capital*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

Office for Greenville County in Plat Book 8, page 41, and having the following metes and bounds, to wit: - Beginning at an iron pin on Pearl Ave, corner of lot No. 4 and running thence N. 3.10 W. 235 feet to iron pin, corner of lot No. 1; thence S. 81.28 E. 51 feet to iron pin, corner of lot No. 9; thence with line of lot No. 9 S. 3.10 E. 219.3 feet to iron pin on Pearl Ave.; thence with said Ave. S. 80.39 W. 51 feet to the Beginning corner.
