SEND GREETING:

WHEREAS, *I*, the said *R. A. Jones*

in and by *my* certain promissory note in writing, of even date with these presents *made* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full

and just sum of *Thirteen Hundred* Dollars,

to be paid on or before the date when the *3rd* Series of the *Installment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I*

All these two certain pieces parcels of lots of land situate in Greenville Township, Greenville County, State of South Carolina, near the Judson Mill property and being known and designated as lots nos. 2 and 3 on plat of property of M. C. Jimison, deceased, recorded in the R. M. C. office for the County and State aforesaid in Plat Book 6, page 161, and having the following metes and bounds and courses and distances, to-wit:
