WHEREAS, *I*, the said *F S Mc Mann*

in and by *my* certain promissory note in writing, of even date with these presents *and* well and truly indebted to *GREENVILLE* AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Two hundred and Fifty* Dollars,
