SEND GREETING:

WHEREAS, *I*, the said *Emily E. Bradley*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Four Hundred (\$400.00)* Dollars, to be paid on or before the date when the *Series of the Installment*
