I *Natie M. Hill* of the state and county aforesaid

SEND GREETING:

WHEREAS, I, the said *Natie M. Hill*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Three Thousand (\$3000.00)* Dollars,

to be paid on or before the date when the *5th* Series of the *Installment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me* the said *Natie M. Hill*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that lot of land situate in the state and county aforesaid, near the city of Greenville, and near the Woodside Mill property, designated as lot no. 9 in subdivision of Donwood, said lot has a frontage of 50 feet on Woodside Avenue and runs back in parallel lines to a depth of 150 feet and is the same conveyed to me by J.
