WHEREAS, *I*, the said *W. W. Meredith*

in and by *my* certain promissory note in writing, of even date with these presents *1922* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Eleven Hundred* Dollars, to be paid on or before the date when the *6th* Series of the *Installment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I*

fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERI-

CAN BUILDING AND LOAN ASSOCIATION All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, known as lots Nos. 5 and 6 of Block E, in the Subdivision known as Summit View, plat of which is recorded in R.M.C. Office for Greenville County in Plat Book A, page 75, and having the following metes and bounds according to said plat: Beginning at a stake on the north side of Creole Street, corner of lot No. 4, which stake is 200 feet from the corner of the New Cut Road and Creole Street, and running thence with the line of Lot No. 4, N. 26-20 E. 150 feet to stake; thence in a northwesterly direction 100 feet to stake at corner of Lot No. 7; thence with line of Lot No. 7, S. 26-20 W. 150 feet to stake on Creole Street; and thence with Creole Street 100 feet to the beginning corner.
