KNOW ALL MEN BY THESE PRESENTS, That R. L. Meares

of the County and State aforesaid, hereinafter called parties of the first part, whether one or more, SEND GREETING:

WHEREAS, The said parties of the first part are indebted in and by a certain promissory note of even date herewith for the principal sum of Twenty-five Hundred + 20/100 (\$ 2,500.00) Dollars, payable to the order of The Federal Land Bank of Columbia, a corporation created, organized and existing under and by virtue of an Act of Congress of the United States of America entitled "The Federal Farm Loan Act," bearing interest at five and one-half (5 1/2) per centum per annum from date to and including the first day of January 1923 which shall be known as the preliminary interest payment, and thereafter with interest on the whole amount of said principal sum remaining from time to time unpaid at the rate of five and one-half (5 1/2) per centum per annum payable semi-annually, both principal and interest being payable on an amortization plan, in sixty-eight (68) semi-annual installments of (\$ 81.25) Dollars and twenty-five (25) cents, each, and a final installment of (\$ 81.02) Dollars and two (2) cents, the first installment being payable on the first day of January 1923, and the next installment on the first day of January 1924 and each successive installment on the same day of each succeeding year thereafter until the entire principal sum is paid in full, and providing that in event of default in the payment of any installment or installments in accordance with the terms thereof, the same shall bear simple interest from date of such default until paid at the rate of eight (8%) per centum per annum, and providing further that after five years from date, and on any regular installment date, an additional payment on the principal may be made in such an amount that shall be equal to one or more of the annual payments on the principal as ascertained from the amortization tables prescribed by the Federal Farm Loan Board, or the entire principal sum may be paid; all of which, and such other terms as therein contained, will more fully appear by reference to said note.

All that certain tract of land in Fairview Township, State of South Carolina, partly in Greenville and partly in Laurens Counties, containing 132.3 acres, more or less as shown on plat by W. M. Nash, Surveyor, copy of which plat is on file with the Federal Land Bank of Columbia and bounded on the north by lands of Mrs. R. L. Peden, on the east by Meely Ferry Road and lands of R. L. Meares, on the south by lands of J. L. Gray and on the west by lands of Jas. Gallison and Mrs. M. R. L. Peden, and being the same land conveyed to R. L. Meares by S. M. Meares by deed dated March 2 1890, recorded on December 5, 1892 in Laurens County in the office of R. M. C. in Book 5 at page 271 and recorded in R. M. C. office for Greenville County in Book 74, page 438, on the 23rd day of June 1922.
