interest be at any time past due and unpaid, then the whole amount hereof by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of per centum

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference

All that certain lot or parcel of land situate, lying and being
in the City of Greenville, in Greenville County, South Carolina
on the west side of McSee street, and being known and
designated as Lot number fifty-four as shown on plat of
record on the lower half of page 97 in Plat Book "C" in
the office of the R.M.C. for said County and State, and
having the following meters and bounds, to-wit:

Beginning at an iron pin, corner of Lot no. fifty-five
(which pin is one hundred two feet from the southwest
corner of Turpin Avenue and McSee street) and running
thence with the line of Lot no. fifty-five South 80 degrees
west one hundred fifty-five feet to an iron pin on a
ten foot alley; thence with said alley South 21 degrees
45 min. East, fifty-one feet to an iron pin corner of
Lot no. fifty-three; thence with the line of said lot North
80 degrees East one hundred fifty-five feet to an iron
pin on McSee street; thence with McSee street North
21 degrees 45 min. West fifty-one feet to the beginning
