with interest thereon from date 7/65 at the rate of 8 per cent. per annum to be
computed and paid semi-annually

and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of
