 in the full and just sum of One note dated January 1st 1920, for Fifteen Thousand Dollars, to be paid (\$15,000.00) Dollars, but reduced to Eight Thousand Fifty Four + 86/100 (\$8,054.86) Dollars with interest from January 1st 1921, at 7% until due after it becomes due at 8% instead of 7% and one note for One Hundred Sixty + 00/100 (\$167.00) Dollars dated July 19th 1922 interest from date at 8% per cent, the last mentioned note becoming due December 1, 1922 with interest thereon from

computed and paid annually, at the rate of per cent per annum to be

8% per annum, payable annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent (10%)
