with interest thereon from date at the rate of 8 per cent. per annum to be
computed and paid monthly

paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, aliened, released, and by these Presents do
grant, bargain, sell and release unto the said H.P. Burbage. All that piece of land situate in the County

and State aforesaid, just outside the limits of the City of Greenville, S.C. on the Laurens
Road, in what is known as Hampton Annex, and being known as Lot #20 on plat made by
C.M. Furman and having the following metes and bounds, to-wit:

Beginning at a point on Darwin Ave. and running thence with said Ave. N. 32-30 E. fifty
feet to corner of lot #21; thence in a northwesterly direction 157.98 feet to a point
adjoining Beaverduck Mill property; thence S. 31.35 W. fifty feet to a point adjoining lot
#19 and Beaverduck Mill property; thence S. 57-30 E. 157.11 feet to the beginning corner.
