to be paid on or before the date when the 10 Series of the Instalment

AND LOAN ASSOCIATION All that certain lot or parcel of land situate, lying and being near the City of Greenville, and better known and designated as Lot No. 7 of the property of Mary B. Lewis, as shown on a plat of record in the R.M.C. Office for Greenville County in Plat Book "F" at page 136, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Conestee Avenue, joint corner of Lots Nos. 7 and 8; thence with the joint line of said lots S. 62-50 E. 170 ft. to an iron pin; thence along the rear line of lots Nos. 1 and 2 N. 27-10 E. 89.1 ft. to an iron pin in line of Carey property; thence along line of said property N. 68-30 W. 173 ft. to an iron pin on Conestee Avenue; thence along Conestee Avenue S. 27-10 W. 70 feet to the point of beginning.
