..... Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

lots of land in Greenville Township, Greenville County, State of South Carolina, about two miles north of Greenville County Court house, near the Paris Mountain Road, and being known and designated as lots 15 and 16 on a plat recorded in Plat Book C page 122 said lots having a frontage of 50 feet each on Cothran Street and a depth of 95 1/2 feet, being the same lots of land conveyed to J.
