All that certain lot or tract of land in Greenville Township,

Greenville County, South Carolina, known as Lot No. 20 on plat of lands of Pride & Patton Land Company made by R.E. Dalton, Engineer, and recorded in office of R.M.C. for Greenville County in Plat Book E, page 249, said lot having the following courses and distances according to said plat:
Beginning at an iron pin on the North side of Judson Road, corner of lot No. 19, which pin is 350 feet N. 53-45 W. from the intersection of Judson Road and Valley Street, and running thence with line of lot No. 19 in a northeasterly direction 211 feet to stake, joint corners of lots 19, 20, 25 and 26; thence in a northwesterly direction with line of lot No. 25, 55 feet to stake, joint corners of lots 20, 21, 24 and 25; thence with line of lot No. 21, 211 feet to iron pin on Judson Road, and thence with Judson Road S. 53-45 E. 55 feet to the beginning corner.
