WHEREAS, I, the said J.J. Turbeville

and just sum of Twenty-five hundred Dollars,

to be paid on or before the date when the 6th, Series of the Instalment

AND LOAN ASSOCIATION All that certain piece, parcel or lot of land in the County

and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatenah", and situated on the South side of Oregon Street and known as Lot #2 of Block B, on plat of the said property recorded in R.M.C. Office for said County in Plat Book F, at pp. 66 - 67.

The said lot has the following metes and bounds: Beginning at a stake on said Oregon Street 60 feet east of the corner of Mitchell Street, at corner of lot #1 on said block, and running thence along said Street N. 63-30 E. sixty feet to stake at corner of lot #3; thence along said lot S. 26-30 E. one hundred and sixty-five feet to a stake at rear; thence S. 63-30 W. sixty feet to a stake at corner of lot #1; thence along said lot N. 26-30 W. one hundred and sixty-five feet to the beginning point on said Oregon Street.
