WHEREAS, I, W.E. Campbell, the said W.E. Campbell

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full

and just sum of Twenty-one hundred and fifty and no/100 Dollars,

to be paid on or before the date when the 8th Series of the Instalment

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

I fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear

AND LOAN ASSOCIATION All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, and County of Greenville, in Paris Mountain Township, near the Paris Mountain Road, and having the following lines, metes and bounds, to-wit: Beginning at a stake on the southeast side of a 16 foot Street and running thence S. 60-17 E. along said 16 foot Street 75 feet to a stake; thence S. 22-52 W. 151 feet to a stake; thence N. 60.17 W. 75 feet to a stake; thence N. 22.53 E. 151 feet to the beginning corner, and bounded by lands of L.E. Hunt, et al. This being the northwest portion of the land conveyed to W.P. Campbell by L.E. Hunt and conveyed to me by W.P. Campbell by deed dated 28th, day of July 1922 and recorded in the R.M.C.
