WHEREAS, I, the said C.R. Worthy

in and by my certain promissory note in writing, of even date with these presents well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full

and just sum of Two thousand nine hundred twenty-five & no/100 Dollars,

to be paid on or before the date when the 8th, Series of the installment

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full, and if

All that certain lot of land, situate in Greenville Township, State and County aforesaid, on the Southern side of Lafayette Street just outside the City limits of Greenville, being Lot No. 17 of Washington Heights subdivision according to a plat made by C.M. Furman, Jr., February 3, 1922 and recorded in Plat Book F, at page 54; said lot fronting 35 feet on Lafayette Street and having a depth on its eastern side of 99.70 feet and on its western side of 99.75 feet.
