with interest thereon at the rate of 8 per cent. per annum to be computed and paid on demand

and will paid in full; all interest not paid when due to bear interest at the same rate as principal. and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent of the whole amount due

grant, bargain, sell and release unto the said W.N. Cruikshank, his heirs and assigns, all that lot of land,

situate in Ward Six of the City of Greenville, State and County aforesaid, on the south side of East Prentiss Avenue, known as Lot #3, of the Thos. I. Charles property and shown on plat filed in plat book F, page 81, in the R.M.C. Office for Greenville County and having the following courses, to-wit:

Beginning at an iron pin, corner of lot #4 on Prentiss Ave. and running thence with line of said Avenue N. 77-57 W. 54 feet to an iron pin, corner of lot #2; thence with line of lot #2, E. 14-25 W. 115.2 feet to an iron pin corner on a fifteen foot alley in the rear; thence with line of said alley S. 53-03 E. 43 feet to an iron pin, corner of lot #4; thence with line of lot #4, N. 20-29 E. 124.4 feet to the beginning corner, and having thereon a new six room, composition roof, one story house.
