 released, and by these presents do grant, bargain, sell and release unto the said Mattie F. Miller

all that piece, parcel, tract or lot of land situated in

Township, Greenville County, State of South Carolina, about one mile from Greenville
Court House on the old Paris Mountain Road,
 beginning at an iron pin on the west side of
 said road and running thence with said road
 N. 18° 45' W. ninety-seven (97) feet and eight (8)
 inches to an iron pin at corner of lot of
 James Dawkins: thence with Dawkins line
 N. 71½ C. one hundred seventy-five feet to an
 iron pin on an alley in rear of lot of
 Lykendall: thence with said alley, S. 6-30 E.
 One hundred (100) feet to an iron pin at corner
 of lot of Dr. Williams: thence with his line
 P. 71½ C. one hundred and ninety-six feet
 and seven inches to the beginning corner,
 being believed as lot No. one hundred ninety
 three on a plat of the Hammett Lands made
 by Wm T. Lee, Surveyor, November 3, 1903,
 being the same lot of land conveyed to me
 by Piedmont Realty Company on the 21st
 of February, 1911 by deed recorded in R.M.C.
 office for Greenville County in Book xxx
 page 181.

All that certain lot of land in the
 township, county and state aforesaid,
 about two and one half miles from
 Greenville Court House on Hammett street,
 and bounded as follows: Beginning at
 the corner lot conveyed by Mallory Dawkins
 to Jerry Smith, and runs thence with his
 line eighty-nine feet (89) to a P.O. Thence
 south seventeen-one and one half (71½) feet;
 thence west thirty and one half (30½) feet
 to corner of lot of R.R. Phillips: thence with
 his line to Hammett street: thence with
 said street north 48-30 east one hundred
 and eight and one-half (188½) feet to the
 beginning corner.
