All that certain piece, parcel or tract of land situated, lying and being in the State and County aforesaid and in Oneal Township and having the following metes and bounds, to-wit: Beginning at stake in Bramlett's Bridge Road, thence N. 43-1/4 W. 10.24 chains to stake in road; thence S. 1/2 E. 19.10 chains to stake in branch; thence down said branch as a line 9.47 chains to a stake in branch N. 15-1/2 E. 1.06 to a stone; thence S. 89 E. 1.72 chains to Bramlett's Bridge Road; thence along said road N. 33-1/4 W. to angle in road; thence along road N. 13 W. 6.68 chains to beginning, containing ten and 86/100 acres, more or less and bounded by lands of J.J.
