interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of .....

South Carolina, adjoining land of A. Rothschild, W. H. Austin  
and others and containing 21 acres more or less, and  
having the following metes and bounds, to-wit: Beginning  
on a stone, Tacao Meares line, thence N. 37 1/2 E. 24.85 chains  
to a stone, thence S. 80 W. 18.95 chains to a stone, thence  
S. 25 W. 12 chains to a stone, thence S. 56 E. 9.88 chains to
