E. L. Little  
in the full and just sum of One Thousand (\$1000.00)  
Dollars, to be paid as follows: Five Hundred (\$500.00) Dollars due and  
payable one year from date; Five Hundred (\$500.00) Dollars due  
and payable two years from date. Full the right of anticipation  
of all or any part of said sum

with interest thereon, from date at the rate of 8 per cent. per annum to be  
computed and paid annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent.

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

in hand well and truly paid by the said E. L. Little

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said E. L. Little, All that certain piece, parcel and lot of land  
situate, lying and being in the County and State aforesaid, and in the City of Greenville, and  
having the following metes and bounds, to-wit: Beginning at the Northwest corner of Nona and  
Haynie Streets and running thence along Nona Street N. 15-1/2 W. 66 feet; thence S. 81 W. 156  
feet; thence S. 15-1/2 E. 66 feet to Haynie Street; thence along Haynie Street N. 81 E. 156  
feet to the beginning corner, and being the same lot of land this day conveyed to me by the  
said E.L. Little.
