at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said *W. T. Henderson and C. B. Martin* all that certain parcel or lot of land situate, lying and being in the City of Greenville, County and State aforesaid, on the South Side of M<sup>o</sup> Fuell Street, being known and designated as lot No. 82 and the rear portion of lot No. 78 on plat of Alta Vista, property of R. B. R. Land Development Company; said plat being of record in R. M. C. Office for Greenville County in Plat Book G. at page 20, and according to said plat more particularly described as follows:

Beginning at point on South side of M<sup>o</sup> Fuell Street at joint corner of lots 81 and 82 and running thence along line of lot 81, S. 4-15 W. across the width of lot 78, 241.3 feet to point on joint line of lots 77 and 78; thence along line of lot 77, S. 85-45 E. approximately 126 feet to rear corner of lots 77 and 78; thence N. 1-0 E. 65.1 feet to corner of lot 83; thence N. 85-45 W. 65.1 feet to joint corner of lots 82 and 83; thence along line of lot 83, N. 4-15 E. 175.1 feet to point on M<sup>o</sup> Fuell Street; thence along M<sup>o</sup> Fuell Street, S. 84-35 W. 59 feet to the beginning corner. This being the same property conveyed to me by The South Carolina National Bank of Charleston, S. C., as Trustee, by deed dated 3rd day of December 1927, recorded in the office of R. M. C. for Greenville County in Deed Book 116, at page 289.
