WHEREAS, I, the said W. D. Norman

in and by my certain (Provisionary) note in writing, of even date with these presents, well and truly indebted to Farmers Loan and Trust Company a corporation under the laws of the State of South Carolina, in the full and just sum of Five Hundred

Dollars, to be paid One year after date

with interest thereon from Date at the rate of 8 per cent. per annum, to be computed and paid semi-annually

Yeager made by R. E. Walter Esqr. Oct. 1922 and recorded in plat book 2 at page 141 and having the following metes and bounds to-wit: Beginning at an iron pin on the south side of Blessingame Street, joint corner of lots nos. 5 and 6 and running thence with line of lot no. 5 S. 26-30 E. 199.4 feet to a point in line of property of J.
