with interest thereon from date at the rate of 6 per cent per annum, to be computed and paid semi-annually.

Pilot Life Insurance Company - All that certain lot or parcel of land, with an Apartment House and outbuildings thereon, situate, lying and being at the Southeast corner of Madison and West Washington Streets, in the City of Greenville, South Carolina, described as follows:

Beginning at the Southeast corner of West Washington and Madison Streets; thence with Madison Street S. 42 W. 150 feet to a stake; thence S. 48 E. 66 feet to a stake; thence N. 42 E. 150 feet to a stake on south side of Washington Street; thence with Washington Street N. 48 W. 66 feet to beginning and being the identical property conveyed to me by Roy R. Smith by deed recorded in the R.M.C. Office for Greenville County in Volume 92, at page 488.

And it is understood and agreed that this mortgage is executed and accepted upon the following conditions:-

That the mortgagor shall insure his life in some reputable insurance company, doing business in the State of South Carolina, in a sum not less than thirty thousand (\$30,000.00) Dollars, and shall keep the said policy of insurance in force during the period for which said notes and mortgage shall run, when said policy of insurance shall be assigned to the Company herein, as collateral security for the debt hereby secured, and in the event of the death of said assured during the period for which said notes and mortgage may run, it shall be the duty of the Company herein named, at the request of the holder of said notes and mortgage, to declare all of said indebtedness due and payable immediately, to collect the amount due on the said policy of insurance, and apply the proceeds to the payment of any of said indebtedness then remaining unpaid, together with all interest and any sums paid by the holder or holders of the said notes and mortgage, for taxes, insurance, or to remove prior liens or encumbrances and to the discharge of the debt hereby created, including any expenses incurred in discharging said debt, rendering the over-plus, if any, to the legal representatives of the mortgagor, or to the beneficiary, or beneficiaries, under said policy or policies, as the case may be; but, if the mortgagor shall fail to pay the premiums on the said policy, or policies of insurance as the same shall become due and payable, then upon the application of the guarantor, it shall be the duty of the Company hereinabove named to declare all of the said indebtedness immediately due and payable and to advertise and convey the said property and distribute the proceeds as hereinbefore set out.
