Township, Greenville County, State of South Carolina,

On the East side of the Bunccombe Road about $\frac{3}{4}$ miles from Greenville Township, and having the following metes and bounds:

Beginning at a point on the East side of Bunccombe Road near an iron stake being the Northeast corner of P. G. Stuart's land and running with said Stuart's line N. 88 E. 635 $\frac{1}{2}$ feet to an iron spur corner of T. L. Land thence with T. L. line N. 83 $\frac{3}{4}$ W. 31 $\frac{1}{2}$ feet to a point $\frac{1}{2}$ E. of an iron stake at corner of L. A.
