all that piece, parcel, tract or lot of land situated in Township, Greenville County, State of South Carolina, about 2 1/2 miles north of Greenville Court House, near the Old Jones Gap Road, containing 155 acres, more or less, being all of a tract of 200 acres conveyed to me by D.
