in the State aforesaid, SEND GREETING:

WHEREAS, *A. D. Stokes*in and by *me* certain Bond or Obligation of even date herewith stand firmly held and bound unto CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, in the full sum of*Four Thousand Six Hundred Sixty Seven Dollars and 67/100* Dollars,conditioned for the payment of the monthly sum of *Sixty Six Dollars and 67/100* Dollars,on the ~~first~~ *fifth* of each and every month succeeding the date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for*ten percent* attorney's fees, in case of suit or of collection by or through an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also in consideration of the further sum of THREE DOLLARS, to *me* to say *A. D. Stokes*

in hand, well and truly paid by the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged,

the said *A. D. Stokes* have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, in the City of Greer, on the *east*side of *Cannon* Street.

Beguning at an iron pine on the east side of Cannon Street at point 198.5 feet in a southerly direction from the intersection of said Cannon Street with Brinklow Ave at corner of Lot #3 and running thence west line of Lot #3 in a southwesterly direction 115 feet to an iron pine on line of Lot #5 thence in a southerly direction with line of Lots #5 and #7 82 feet to an iron pine, corner of Lots 6 and #4 thence N. 61 30' W 137.4 feet to an iron pine on Cannon Street thence with Cannon Street N. 31 6' 78.5 feet to the beginning corner being known and designated as Lot #6 on plat of the property known as Cannon Heights prepared by H. G. Bailey & C. C. in 1920 which plat is recorded in O. M. C. Office for Greenville County in Plat Book 6, Page 214 & and being the same lot of land conveyed to me by Allie B. Hawkins by deed recorded in O. M. C. Office for Greenville County in Vol. 71 Page 69 also an easement for water and sewerage line through lot No. 7 to Line Street.
