on the fifth of each and every month succeeding the

date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for

ten per cent

attorney's fees, in case of suit or of collection by or through

an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said N.A. Harrison

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to me to said N.A. Harrison

in hand, well and truly paid by the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, I, the said N.A. Harrison

have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, near the City of Greer, on the North

side of Nat. Highway Street.

All that certain lot, piece or tract of land, situate, lying and being in the State and County aforesaid, in Chick Springs Township, on the West side of Greer, on the north side of the National Highway, and having the following metes and bounds, to-wit:-

Beginning at a stake on said National Highway, corner of lot No. 6 and runs thence N. 8.27 E. 181 feet to a stake on lot No. 7; thence along the line of lot No. 7, S. 87.50 W. 70 feet to a stake on the back corner of lot No. 4; thence along the said lot S. 8.27 W. 181 1/2 feet to a stake on the said National Highway; thence along the said Highway N. 87.50 W. 70 to the beginning corner. The same being all of lot No. 5 on plat of land known as the R.L. Ford lots, and being the same lot deeded to me by the said R.L.
