conditioned for the payment of the monthly sum of *Thirty-three and 3/100* Dollars,

on the ~~first Tuesday~~ *fifth* of each and every month succeeding the

date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for *ten per cent*

attorney's fees, in case of suit or of collection by or through

an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being

thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That *I*, the said *L. R. Ross*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said bond; and, also, in consideration of the further sum of THREE DOLLARS, to *me* to said *L. R. Ross*

in-hand with and to be paid by said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, *I*

have granted, bargained, sold and released and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of *land* in said State and County, *near* the City of Greer, on the

*side of* Street

having the following meter and bounds, to-wit:

Beginning at an iron pin on an unnamed street and run thence with said street N. 14-45 E. 55 feet to the corner of lot #6; thence

along the line of this lot S. 56-45 E. 150 feet to the line of lot #8; thence along the line of this lot S. 14-23 W. 55 feet to Duncan line, thence along this line N. 56-45 W. 150 feet to the beginning corner and being designated as lot #7 on a plat of the R. S. Ford property made by H. S. Brookman, Surveyor, February 23, 1924.

Also, all that other lot of land adjoining the above described lot and having the following meter and bounds, to-wit:

Beginning on an unnamed street at the corner of lot #7 and run thence with said street N. 14-45 E. 55 feet to the corner of lot #5; thence along the line of this lot, S. 56-45 E. 150 feet to line of lot #8; thence along the line of this lot S. 14-23 E. 55 feet to the corner of lot #7; thence along the line of this lot N. 56-45 W. 150 feet to the beginning corner, and being designated as lot #6 on said plat. The above being the same two lots conveyed to me by R. S. Ford by deed dated December 29, 1924. This is the first mortgage.
